MR. ERVIN: Hello. Kent Ervin, E-r-v-i-n, representing the Nevada Faculty Alliance, the independent association of professional employees at our public colleges and universities statewide.

Regarding the legislative update, the NFA continues to oppose AB22 which will remove the authority of the PEBP Board over final approval of contracts, which is a fiduciary duty of the board. We also oppose SB32 which will eliminate the quality control officer from statute. PEBP

needs to improve customer service and provide better assistance to participants who have difficulty navigating their benefits among PEBP contractors.

NFA strongly supports AB188 which would restore retiree health benefits for State employees hired after 2011. We have provided a fact sheet on AB188 as written public comment. Adding back these benefits with a minimum of 15 years of service would, at most, require a modest increment in the fringe rate on State salaries that funds retiree health benefits on a pay-as-you-go basis.

At the March meeting, Executive Officer Glover indicated that she could only testify in neutral on bills despite having presented AB22 and SB32 in hearings on behalf of PEBP. However, PEBP's own written Board and agency's duties, policies and procedures document specifies that the PEBP Board has the responsibility over positions on bill: Quote, Board members are entrusted with the responsibility of ensuring efficient administration of the program in accordance with all applicable laws and regulations and shall, among other items, take a position on any proposed legislative matters affecting the program and direct agency employees to make that position known to the legislature. During the legislative session, the Board authorizes the Executive Officer to take a position of neutral on any new bill

affecting the program by default. This allows for the rapid response to legislative committee meetings scheduled prior to a Board vote. The Board can revise the default position at the next board meeting, end quote.

Thus, the Board -- the PEBP Board not only may take a position on a bill; it is your stated responsibility to do so on bills that affect the program.

Board members, if you have not recently reviewed the PEBP duties, policies and procedures manual, I recommend that you do so. It was last revised and published in the Board packet at the January 28, 2021, board meeting.

MS. LAIRD: Good afternoon, Chair Grimmer, fellow Board members, Executive Officer Glover, and PEBP staff. My name, for the record, is Terri Laird, T-e-r-ri L-a-i-r-d. I'm the executive director at RPEN, Retired Public Employees of Nevada, founded nearly 50 years ago and currently has nearly 7,000 members and 17 chapters statewide.

Our team is already on the record opposed to

AB22 and SB32 during your last legislative meeting, as well as

during initial hearings on both bills, so we do remain opposed to both measures for reasons already mentioned by

Dr. Ervin.

In regard to the April 15th upcoming PEBP budget hearing, we also remain hopeful that an increase in the health reimbursement arrangements, HRAs, for Medicare retirees in the Medicare exchange will be included during the budget hearing. We tried to get that passed at the last session and were unable to do that, and we're hopeful that that will be considered.

Additionally, we wholeheartedly support AB188 from Assembly Member Max Carter that seeks to restore retiree health benefits for post-2011 hires.
