## AVAILABLE VACCINES\*

Vaccine Type	Vaccine Administration Cadence
Flu	Everyone 3 years and older every flu season.
COVID-19	Everyone 3 years and older. You cannot have had another dose within the last four months to receive another dose.
RSV	Adults 75 years of age and older, pregnant women from week 32 through 36 weeks and people 60-74 who are at increased risk due to certain medical conditions are eligible.
Tdap (Tetanus, Diphtheria, Pertussis)	For children 7 years or older, pregnant women during the early part of their third trimester and adults every 10 years.
Hepatitis B	Unvaccinated adults 19 - 59 and adults 60 years of age or older without known risk factors. Vaccine may be given over 2-3 doses, two to six months apart. If over 60, Medicare may not cover this.
Pneumococcal	Adults 65 years or older. You must meet the age requirements to be considered preventive and covered at \$0 copay. Standard copayment will apply if filled outside the specified age limits.
Shingles	Adults 50 years and older. You must meet the age requirements to be considered preventive and covered at \$0 copay. Standard copayment will apply if filled outside the specified age limits.

\*Subject to CDC approval. If a new vaccine has been approved prior to the scheduled clinic and the pharmacy has not yet received the shipment of the new vaccine, the old vaccines may not be administered.

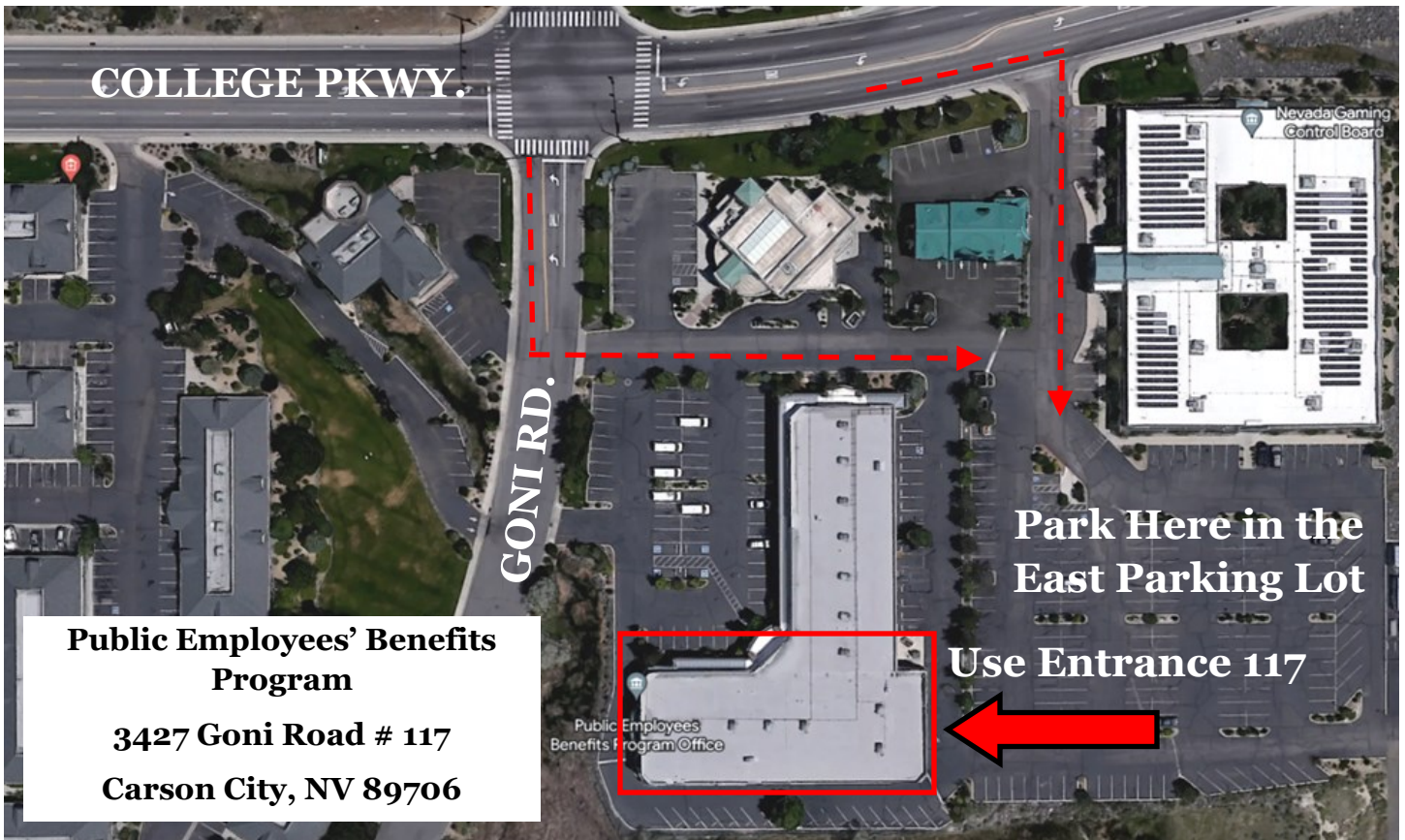

The **shingles vaccine** is taken in two doses, two to six months apart. For additional doses, schedule an appointment at a participating in-network pharmacy, or schedule an appointment with your primary care provider (PCP). Administrative leave is authorized per NAC 284.589.6(b) for **active employees** attending a PEBP coordinated event. PEBP recommends employees work with their supervisor to request approval to attend a clinic.
