#### <u>1. Pre-Medicare—Aging</u> into Medicare Meeting

This meeting is for those

still enrolled in a PEBP selffunded plan or Health Plan of Nevada (HMO) who have not yet enrolled in Medicare and would like an overview of how to make the transition once they turn 65 or retire after age 65. This meeting provides an overview of PEBP's Medicare requirements, the enrollment process, and the Exchange HRA funding for eligible retirees.

2. Exchange HRA/Medicare Open Enrollment—Already Enrolled with Via Benefits
